

Website Privacy Policy

Anne Giancola ("**Company**", "**we**", "**us**", or "**our**") respects your privacy and is committed to protecting it through our compliance with this policy. This policy describes the types of Personal Information we may collect from you or that you may provide when you visit the website Anne-Giancola.art and any associated web-based services (our "**Website**") and our practices for collecting, using, maintaining, protecting, and disclosing that information. "**Personal Information**" means individually identifiable information such as names, contact information, and other personal identifiers.

This policy does not apply to third-party websites, products, or services, even if they link to, or are linked from, our Website. These external websites may have different privacy policies from the Website and we are not responsible for the privacy practices of such external websites. We encourage you to read all privacy policies posted on the web sites that you visit. This policy also does not apply to any Personal Information that may be collected by us offline.

Please read this policy carefully to understand our policies and practices regarding your Personal Information. By accessing or using this Website, you consent to this privacy policy. We ask that you do not use the Website if you do not consent to any of the provisions of this policy. This policy may change from time to time (see Changes to Our Privacy Policy). Your continued use of this Website after we make changes is deemed to be acceptance of those changes, so please check this policy periodically for updates.

1. Information We Collect About You and How We Collect It

We may collect the following types of Personal Information from and about you through our Website, including information:

a. Information You Provide to Us

We may collect the following Personal Information about you that you choose to provide us through our Website:

- Contact information, such as your name, email address, phone number, postal address, company name, and/or social media user name.
- Information that you provide by filling in forms on our Website. This includes information provided at the time of subscribing to our email list or requesting further services. We may also ask you for information when you report a problem with our Website.
- Other Personal Information that may be contained in your records and copies of your correspondence (including email addresses), that you may send to us.
- Payment card and other financial information that you may provide for payment via Square app, Paypal, or other form of payment.

b. Information We Automatically Collect

When you interact with our Website, we may use automatic data collection technologies to collect Personal Information in order to track and report website traffic. This may include:

- Details of your visits to our Website, including traffic data, location data, logs, and other communication data and the resources that you access and use on the Website.
- Information about your computer and internet connection, including your IP address, operating system, and browser type.

The information we collect automatically is only statistical data and does not include Personal Information. It helps us to improve our Website and to deliver a better and more personalized service.

The technologies we may use for this automatic data collection may include:

- **Cookies (or browser cookies).** A cookie is a small file placed on the hard drive of your computer. You may refuse to accept browser cookies by activating the appropriate setting on your browser. However, if you select this setting you may be unable to access certain parts of our Website. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies when you direct your browser to our Website.
- **Flash Cookies.** Certain features of our Website may use local stored objects (or Flash cookies) to collect and store information about your preferences and navigation to, from, and on our Website. Flash cookies are not managed by the same browser settings as are used for browser cookies. For information about managing your privacy and security settings for Flash cookies, see Choices About How We Use and Disclose Your Information.
- **Web Beacons.** Pages of our Website and our emails may contain small electronic files known as web beacons (also referred to as clear gifs, pixel tags, and single-pixel gifs) that permit the Company, for example, to count users who have visited those pages or opened an email and for other related website statistics (for example, recording the popularity of certain website content and verifying system and server integrity).

We do not collect Personal Information automatically, but we may tie this information to Personal Information about you that we collect from other sources or you provide to us.

c. Third-Party Use of Cookies and Other Tracking Technologies

Some content or applications, including advertisements, on the Website are served by third-parties, including advertisers, ad networks and servers, content providers, and application providers. These third parties may use cookies alone or in conjunction with web beacons or other tracking technologies to collect information about you when you use our website. The information they collect may be associated with your Personal Information or they may collect information, including Personal Information, about your online activities over time and across different websites and other online services. They may use this information to provide you with interest-based (behavioral) advertising or other targeted content.

We do not control these third parties' tracking technologies or how they may be used. If you have any questions about an advertisement or other targeted content, you should contact the responsible provider directly. We may use third-party service providers to monitor and analyze the use of our Platform. Google Analytics is a web analytics service offered by Google that tracks and reports website traffic. Google uses the data collected, including your IP address, to track and monitor the use of our Sites and Platform. This data is shared with other Google services. Google may use the collected data to contextualize and personalize the ads of its own advertising network. d. How We Use Your Information

We use your Personal Information for the following purposes:

- To present our Website and its contents to you.
- To provide you with information, products, or services that you request from us.
- To carry out our obligations and enforce our rights arising from any contracts entered into between you and us, including for billing and collection.
- To comply with legal obligations and to protect and defend the rights, interests, and property of us, you, and others
- To notify you about changes to our Website or any products or services we offer or provide through it.
- In any other way we may describe when you provide the information.
- For any other purpose consistent with your consent.

e. Sharing of Your Information

We may share your Personal Information as follows:

- To our subsidiaries and affiliates.
- To contractors, service providers, and other third party partners that we may use to support our business.
- As part of a business transaction, subject to applicable law, in the event of a merger, acquisition, bankruptcy, or other sale or transfer of all or a portion of our assets.
- To other third parties consistent with our notice to you when you provide the information and/or the circumstances in which you provided the information to us.

In addition, we may disclose aggregated information about our users, and information that does not identify any individual, without restriction.

Choices About How We Use and Disclose Your Information

We strive to provide you with choices regarding the Personal Information you provide to us. We have created mechanisms to provide you with the following control over your information:

- **Tracking Technologies and Advertising.** You can set your browser to refuse all or some browser cookies, or to alert you when cookies are being sent. If you disable or refuse cookies, please note that some parts of this site may then be inaccessible or not function properly.

We do not control third parties' collection or use of your information to serve interest-based advertising. However these third parties may provide you with ways to choose not to have your information collected or used in this way. California Privacy Rights

California residents have the right to request information from Anne Giancola regarding third parties to whom we have disclosed certain categories of Personal Information during the preceding year for those third parties' direct marketing purposes under California's "Shine the Light" law. Personal Information under this California law means "any information that when it was disclosed identified, described, or was able to be associated with an individual."

We do not currently disclose this type of Personal Information to third parties for their own purposes.
